AccuCare uses a concept of program access levels, or 'roles.' Each role is comprised of a set of modules and the permission to access or not access those modules. Some of the modules can be moved between allowed and denied status, while others are essential to the definition of that role and cannot be moved.

As of AccuCare 9.8, there are two categories of roles: clinical and billing:

These roles are available for standard users, and should be used for all day-to-day operations. In addition, a separate class of user called **SuperAdmin** can be created. Users who are set to SuperAdmin status have access to the entire program, including system setup areas that standard users cannot access, such as the ability to create users or manage permissions.

Default patient data access has also been streamlined, to better reflect the categories that exist:

In addition to the specific modules available to each role, a subset of patient data access levels that can be set for users is assigned to that role. The patient data access levels available for any user are only those common to the chosen billing and clinical roles for that user.

For example, imagine we have user Sally S. Sample, the office receptionist. Since she doesn't have a need to access clinical data such as assessments or treatment plans, her clinical role is set to Low-level Admin. However, she also fields customer calls about their balances, her billing role is set to User.

From the tables above, we can see that the only patient data access level she can have is "All patients," since that is the only one common to the clinical Low-level Admin and the billing User.

Now let's say Sally needs to perform some clinical functions, such as printing narrative reports of client assessments. Her clinical role has to be increased, and is set to Clinician. She now has three patient data access levels that are available to her, since "Own patients only", "All patients in own provider", and "All patients" are available to both Clinician and the billing User.

Module Permissions

The following pages document what modules and permissions each role has by default, and whether particular modules can be individually allowed or denied via the Custom tab of User Administration.

Some modules are accessible only to users who are SuperAdmins. These modules and permissions have system-wide ramifications, and should be available only to users whom you trust with the responsibility to access them. In short, *if you do not want users to be able to access these areas, do not make them SuperAdmins*.
